#### LETTER FROM THE PRESIDENT

The Board has prepared proposed changes to the by-laws as outlined on the website for consideration by the membership during our annual meeting on April 15, 2016. These changes have been discussed for several years. Please review the proposed changes prior to the meeting.

The Board believes that the proposed changes to Article XV would create a stronger board with better membership representation. Historically, there have been board openings left unfilled, which have created quorum issues at board meetings. The board is currently composed of nine area directors and four officers. The geographical boundaries for the nine area directors are currently based on Missouri Department of Public Safety areas. Due to variability in membership population distribution, some MfSMA directors have a significant number of members in their districts, while others have very few. Therefore, we propose a revision of geographical districts and also propose to incorporate three at-large board members to allow interested members an opportunity to serve if the area director seat is filled. The proposed change would result in area directors from six districts plus three at-large members.

Proposed changes to Article VII would allow no more than one board member from the same corporate membership or two board members from a specific organization. Article XII proposed changes will raise the allowed expenditures from \$100 to \$500 without specific approval of the president. (Significant MfSMA expenses are always discussed by the board.) We are looking forward to seeing you in April. Please do your taxes early so that you can enjoy the evening fellowship.
